VI. Race Admin Director Report – Matt Hill

a. Update on insurance. NASO.org insurance coming soon via US Sailing group discount. 380 responded, and ½ said they likely or very likely to buy insurance.

Several of us are still unhappy for US Sailing is not paying for insurance. Matt will try to include this in the budget next year.

Matt said So far 350 responses and most said they were likely or better to join. A website will be created to aid signups. Specific questions will get answered. Should be up and running before the end of June.

There was a general discussion on how well input from the Judges' Committee to US Sailing is occurring on items like insurance, LMS and such.

- b. Update on LMS (Learning Management System) platform It may implement in the next couple of weeks. Bill and others will get together. National Faculty meeting in October, want to get the correct people there . 5-year plan, invite Bill. Ready to operate in the Fall. Stu has to set the dates.
- c. Update on Review Board action status. Continuing discussions on the issue and no decision yet.
